

Public institutions, 2003-04, 2008-09, 2013-14 (2013 Dollars)








Enrollments, total appropriations, appropriations per FTE student relative to 1999-00






Average state subsidy per FTE student by deciles, 2015-16

State & local funding for higher education per student and per \$1,000 in personal income by state, 2014-15





Need-based state grant aid as a percentage of total undergraduate state grant aid by state, 2014-15






State and local appropriations and federal aid over time



The role of targeted grant aid


- Preparation for college
